As the 2021-22 Legislative session came to a close Gov. Gavin Newsom signed several waste and recycling bills into law as part of a broader <u>legislative package</u> which includes updates to state incineration rules, battery recycling programs, organic waste diversion efforts and other climate initiatives.

The Governor signed 997 bills into law while vetoing 169 bills.

Among the waste and recycling-related bills is <u>AB 1857</u>, which repeals a part of state law allowing jurisdictions to count up to 10% of the waste sent to "transformation" facilities toward a 50% diversion requirement. It also creates a Zero-Waste Equity grant program for projects that reduce reliance on incineration.

- Gov. Newsom also signed two bills meant to make battery drop-offs easier and reduce collection vehicle and recycling facility fires. AB 2440 establishes an extended producer responsibility program for most batteries. SB 1215 adds battery-embedded products to the state's e-waste program, meaning consumers will begin paying a disposal fee when they purchase applicable products starting in 2026.
- The governor also signed <u>AB 1985</u>, which delays enforcement penalties for jurisdictions to meet their organic waste procurement targets set out in SB 1383.
 Sponsors of the bill say the legislation will give local governments more time to ramp up infrastructure needed to meet the goals. It also allows renewable gas procured from a publicly owned treatment works to count toward a jurisdiction's procurement target until 2025.

Unfortunately, with signing bills into law the Governor must also decide which bills must be <u>vetoed</u>. This included <u>AB 2784</u>, a bill that would have set recycled content standards for thermoform food containers, due to concerns about how it could related to the state's upcoming extended producer responsibility law under <u>SB 54</u> which creates an extended producer responsibility program for printed paper and plastic packaging and sets recycling rates and reductions for plastics.

- A PFAS disclosure bill, <u>AB 2247</u> was <u>vetoed</u> by the Governor stating this bill is
 estimated to cost millions of dollars that would result in increased Environmental
 Fee rates or General Fund resources for the new contract, staff support, and
 state oversight responsibilities. The fiscal impact of this bill should be considered
 and accounted for as part of the annual budget process.
- Lastly, another <u>vetoed</u> bill that could have had the potential to transition towards a reuse program was <u>SB 1256</u> which would have placed a ban on the sale of single-use 1lb propane cylinders in the state. California already has refill and exchange infrastructure for 1 lb. propane cylinders – infrastructure that bill sponsors, CPSC and grant partners, have built across the state over the past seven years.
