On July 10, Mr. Skye attended a public workshop sponsored by the Waste Board's Strategic Policy Development Committee, related to activities regarding bioenergy and biofuels, and provided a presentation detailing the County's conversion technology project. Mr. Skye also attended a stakeholder meeting for Senate Bill 1020 on July 11, where he argued in favor of incorporating conversion technologies into the bill's text. The language of the Bill is still being developed.

# IV. UPDATE ON THE PUBLIC OUTREACH CONTRACT

Mr. Wittenberg provided an update on the public outreach contract. Members of Cerrell Associates met with the public outreach consultants responsible for the City of Los Angeles' conversion technology project in order to coordinate efforts in the future. Cerrell also coordinated meetings on behalf of the County with a number of local environmental groups and will continue to arrange meetings with key stakeholders.

## V. UPDATE ON FACILITATION CONTRACT AND DRAFT FINAL REPORT

Sue Higgins provided an update on the facilitation contract and the draft final report. A copy of the draft report was provided both electronically and physically to Subcommittee members. Comments from the June 9<sup>th</sup> Subcommittee meeting have been incorporated, and ARI is currently working to finish an executive summary to accompany the Report, which should be available by the end of July. Ms. Higgins also discussed the major topic areas of the Report. Comments to be incorporated prior to an August 2 teleconference to finalize the report. Based on the discussion on August 2,

Mr. Mohajer recommended that the company contact Los Angeles County officials regarding the planned project, since the proposed project would reside on County unincorporated property.
