IV. TASK FORCE MEETING DEBRIEFING, Mike Mohajer

The Task Force met on May 17, June 21, and July 19, 2007. At the meetings, they discussed legislative proposals at the State level as well as receiving update from staff on conversion technologies.

Task Force has also expanded its activities to monitor implementation of AB 2296 (2006) in re to the adequacy of the existing financial assurance mechanism for a landfill closure, 30-year post closure maintenance and corrective action(s). As required by AB 2296, the Waste Board has selected a private firm/contractor to evaluate the existing system as well as identifying measures for improvement. The Waste Board has also formed a "working group" to review the contractor's proposals/work products with comments to the Waste Board. Mike Mohajer is the Task Force's representative on the working group.

During the past quarter, the Task Force also received presentations from the City of Los Angeles, Waste Management Inc., 1-800-Got Junk, the Countywide Siting Element update and the Sanitation Districts regarding their Waste by Rail Project with an estimated tipping fee of \$70 per ton.
