Description of Nature, Purpose, and Beneficiaries of Project:

On April 8, 2025, the Board established and approved the acquisition of the new Computed Tomography (CT) equipment for the Los Angeles General (LA General) Medical Center Radiology Program. After Public Works completed design of the project through a Board-approved, on-call architectural/engineering agreement, and obtained plan check approval from the California Department of Health Care Access and Information, Public Works returned to the Board. On December 2, 2025, the Board of Supervisors approved the project budget and authorized the project to be delivered using Board-approved Job Order Contracts.

The LA General Emergency Department CT Equipment Replacement and Room Remodel project consists of remodeling an unoccupied room within the emergency department and the existing control room. The remodeled room will meet current accessibility and seismic code requirements. The new CT scan equipment has been procured by the Department of Health Services through the Internal Services Department, as the County's purchasing agent, and will be installed by the equipment vendor.

The project involves negligible, or no expansion of an existing use and replacement systems will have the same purpose and capacity as systems replaced. Beneficiaries are all patients visiting the hospital, especially those residing in the greater Los Angeles area.

The project provides for repair, refurbishment, and minor alterations of existing facilities involving negligible or no expansion of an existing use and where replacement features will have the same purpose and capacity. Additionally, the project will comply with all applicable regulations, is not located in a sensitive environment, and there are no cumulative impacts, unusual circumstances, damage to scenic highways, listing on hazardous waste sites compiled pursuant to Government Code Section 65962.5, or indications that the project may cause a substantial adverse change in the significance of a historical resource that would make the exemptions inapplicable based on the record of the project.
